#### **Progress report**

After the August Iull I picked up a fair bit of work in the parishes at the start of September, and did my best to make some progress before my trip away for an academic research meeting at Berkeley in California. Unfortunately I then returned from that with covid, so the following week was a write-off too.

#### Flags

We've been engaged in a cross-party initiative to try to get the County Council to speak out against the abuse of British flags-- which should be reserved for honourable, patriotic and celebratory purposes and to support activities of which we could be proud; and also to remove the flags promptly, especially where they're being used to instigate violence, racism and intimidation against vulnerable groups. At the recent full council meeting a motion initiated jointly by Labour and Greens, together with some independents, was passed unanimously (after amendments from the Conservative group). My colleague Serene, Green Party councillor for Mancroft, who was rescued by her father from a warzone as a toddler, made a particularly moving speech. It's worth watching the recording (links and timings are on my facebook page).

Unfortunately there's no budget for the extra cost to Highways in responding to the presence of illegal flags on lampposts and bridges. The extra costs are likely to divert funds from highways maintenance. The current policy is to remove them when teams are in the area to do other work. The dark funding that provides the equipment and resources for putting the flags up is not (it seems) likely to run out. Investigative journalists are beginning to uncover some evidence of where money laundering is happening, and who the funding is coming from. I recommend an internet search on the topic "Flag Force UK". It would be nice if that funding could go into delivering a better life for British people, and activities that promote wellbeing and road repairs, rather than funding displays of hatred that make people afraid to talk to neighbours.

#### Pylons and panels

The push for hideous and damaging energy projects all over South Norfolk continues. Norwich to Tilbury pylons report that their Development Consent Order (DCO) has now been passed to the Planning Inspectorate for examination. I will be registering as an interested party.

The Tasway Energy Park company have organised four local events later in October and November. I shall attend at least some of these.

#### Mayors and unitary councils

The County Council narrowly passed the Council administration's proposed business case for having just one large Unitary Council for the whole of Norfolk. Most opposition councillors and some Conservatives voted against, preferring the idea of two or three unitary councils. I was absent on this occasion due to the covid.

We are expecting the first elections for a mayor for Norfolk and Suffolk (to incorporate the job of police and crime commissioner as well as a range of strategic funds for the area) to take place along with County Council elections next May. Some parties have announced their candidates for the mayoral position.

#### Highways and paths

The BOAT (Byway Open to All Traffic) in Shimpling has now had the bollards removed and to restore the legal right for four wheeled vehicles to use it. We are now collecting information about who is using it and with what kind of mode of transport. Eventually, I hope, we may find a way to change its legal status, but several previous attempts have been unsuccessful.

I took the Highways team to look at three places in the division where we need interventions to help with traffic management and parking. In Upgate Street in Carleton Rode we would eventually like a speed limit but I'm starting in the short term with some signage. In Ashwellthorpe, we are looking to fund physical interventions in the highway to force antisocial drivers to stick to the speed limit even in the wee small hours. We also visited Tacolneston to consider the place where parked cars create a kind of unmarked chicane system. This does force traffic to slow down at the bend, which is a virtue, and there is no easy solution, so maybe we should stick with it. There is a good footway which keeps pedestrians safe, and there have been no accidents.

I've also asked the Highways team to look at the dangerous chasm beside the road where the lorry fell over on Market Lane. No update on that so far.

A disastrous mix up about the resurfacing of the road from Shelfanger to Winfarthing means that the contractors have done top dressing (without any preparatory work), instead of the full resurfacing had been approved. This is worse than useless and very irritating after all the effort put in by the Highways officer to secure the funding for resurfacing. How to put it right? Unclear.

I'm close to feeling sure that I know all there is to know about the rights of way on Hundred Lane in Great Moulton. I'm now exploring some potential new rights of way over two ancient byways in Bunwell, that might provide a good route from the centre of the settlement to the school, church and village hall.

#### **District Councillor Report September 2025**

August and September are normally quiet months at SNC and I have spent a considerable amount of time on the committee preparing the business plan for the 2 unitaries for Norfolk in connection with LGR. The final document has been prepared and debated at full Council meeting on 24-09-25 before being submitted to the Government on 26-09-25. We will then wait, probably until the end of December before a decision is made on which way Norfolk will go.

#### Lotus

As you are all aware Lotus has decided to make 550 employees redundant. No one knows who will be made redundant yet as the company has asked the workforce for those who would like early retirement/redundancy.

In light of this unexpected issue Norfolk CC and SNC are putting together a package of assistance and measures to those who end up being unemployed to assist them to find new opportunities.

The second part is to develop the Hethal site to encourage new engineering companies to set up there, premises, roads and other infrastructure.

#### Homes of Multiple Occupancy (HMO)

Now that the Government has promised to close all hotels to illegal asylum seekers their plan is to open HMO's across the country. This implies that a normal house will be altered to make each room into a bedsit for these people. Obviously to make the system work the Government are offering high rents and incentives to prospective landlords. In the long term this will have a devastating effect on the rental market for those that need accommodation, as more and more properties are taken out of the system. To try and stall this effect on our residents, SNC state that any changes to a property's use needs planning permission. This will enable SNC to see how many properties come forward and the suitability and location of them that the Home Office intended use.

#### **Food waste**

Half of the vehicles needed will be available for the April start; the companies making food waste vehicles cannot keep up with the orders received for this Government project. As soon as more vehicles become available the remainder of the project will be rolled out. The caddies have been ordered and will be delivered to all homes when needed.

However, SNC still has issues regarding parking and storage of the vehicles as suitable premises have not been found.

It is anticipated that a new processing plant will be built in Attleborough to take the food waste and turn it into electricity and fertilizer.

#### **Solar Farms**

The companies that are signing up farmers to use their land for solar farms have now fallen foul of planning regulations and SNC is taking them to task. Especially those that do not comply with regulations and use dubious companies to advise them.

To re-enforce the SNC position you will no doubt have seen in the EDP, the Leader of SNC disposing of a solar farm. SNC is in no doubt that the companies involved with creating solar farms have no regard whatsoever regarding the close proximity to homes or encircling villages with solar farms regardless of the dangers imposed.

#### **Grants**

I have found that the Norfolk Police Crime Commissioner has access to the money from The Police Property Fund, money that is raised from property that cannot be returned to the owner, or no owner can be found. She has donated to some organisations; a list is attached in the leaflet sent.

Of course, it comes with criteria that an application must comply with one of the following:-

Prevent or reduce crime

Improve people's lives

Build stronger safer communities

To apply you must contact the Commissioner's Office for an application form. No doubt you can think of ways to attract some of this money especially as she is asking more groups to apply. The fund is currently closed but will open next year.
